### **Documents Required for Final Registration**

- a) Candidates are required to be headed to the nearest Turkish Foreign Representation in their home country with the Acceptance Letter and get an “Education Visa”.
- b) Candidates in Turkey are required to get a “Residence Permit” from the Provincial Directorate of Migration Management instead of a student visa.
- c) The original of the high school diploma and its Turkish translation approved by the notary public or Turkish Foreign Representations.
- d) The original of “Equivalence Certificate” of the high school diploma obtained from the Provincial Directorate of National Education of the Ministry of National Education of the Republic of Turkey or from Turkish Foreign Representations.
- e) An official transcript approved by the high school directorate showing the courses taken in high school, grades and grade point average of the candidate, and a copy of Turkish translation approved by the notary public or Turkish Foreign Representations.
- f) The printout of the result document for those who matriculated with the YÖS score obtained by the universities in Turkey.
- g) A copy of the pages of passport with the Education Visa showing the identity information and validity period and its Turkish translation approved by the notary public or Turkish Foreign Representations.
- h) If available, a certified copy of the Turkish Proficiency Certificate with international validity from the notary public or Turkish Foreign Representations.
- i) Six 4.5X6.0 cm photographs (which are to be taken with the last six months, from the front, and the candidate should be easily identifiable in those photographs).
- j) Bank receipt showing that the tuition fee has been paid to the relevant bank.
- k) Signed Subsistence Statement.
- l) Foreign Nationals Identity Number.
- m) Health Certificate (Kilis 7 Aralık University may request a committee report from a health institution within the borders of Turkey from students who are matriculated in departments when necessary).

Registrations are made by the candidate in person at the University's Student Affairs Department on the dates announced on the University website.

### **International Student Obligations**

International students are obliged to;

- a)** perform the necessary procedures and obtain the documents (YU Number, etc.) according to Turkish Laws,
- b)** obtain a residence permit from the Provincial Directorates of Migration Management before starting education (within 1 month from the date of entry with a student visa),
- c)** submit the student certificate to the Provincial Directorates of Migration Management every year, based on the residence permits obtained from the Provincial Directorates of Migration Management during their education,
- d)** fulfill the conditions required by the Law, as they are deemed to be Universal Health Insurance holders starting with the date of their Higher Education, pursuant to Law No. 5510,
- e)** notify the Student Affairs Department of changes in personal, marital and educational status within 15 days at the latest.
- f)** obtain a new residence permit from the local Provincial Directorates of Migration Management, within 15 days following the expiry of the period written in their residence permit, provided that they document that they continue their education, if they want to extend their stay during their education,
- g)** apply to the relevant authorities immediately and get a new residence permit or passport within 15 days, in case of losing their residence permit or passport,
- h)** notify the local Provincial Directorates of Migration Management of the places they have left or transferred, within 48 hours, in case they change their educational institutions, residence addresses or contact phones.

### **Language of Education and Turkish Proficiency Levels**

- 1)** The language of education at the university is Turkish.
- 2)** Turkish proficiency levels are determined according to the principles of our university's TÖMER directive. The leave of absence of students who fail this exam in order to study Turkish is decided by the relevant unit administrative boards.
- 3)** Students who are obliged to learn Turkish can attend Turkish courses organized by TÖMER. The training program for the Turkish Course is announced on the website of our university.
- 4)** A student who cannot achieve Turkish proficiency at the end of two years will be deregistered.
