# 2023-2024 EDUCATION PERIOD KİLİS 7 ARALIK UNIVERSITY ADDITIONAL PLACEMENT APPLICATION ANNOUNCEMENT FOR INTERNATIONAL STUDENTS

Applicants Who Can Apply

- a) Students who are in their last year of high school or graduated from high school,
- 1) Foreign nationals, (provided that those studying in secondary education (high school) institutions in Turkey have enrolled before the 2022-2023 academic year [except for embassy schools, international private education institutions included in the MOBİS system and foreign nationals who have been to our country within the framework of the project carried out by the Ministry of National Education]),
- 2) Those who were Turkish citizens by birth but lost Turkish citizenship by obtaining a permission to renounce Turkish citizenship from the Ministry of Interior and those who document that they have a blue card issued to those who have lost Turkish citizenship upon request (provided that those who are studying in secondary education (high school) institutions in Turkey have enrolled before the 2022-2023 academic year) (Article 7 of the Turkish Citizenship Law No. 5901. Article 7 of the Turkish Citizenship Law No. 5901 stipulates that "(1) A child born within or outside Turkey to a Turkish citizen mother or father within the union of marriage is a Turkish citizen." and it is beneficial for candidates who will apply for admission quotas from abroad to examine the Turkish Citizenship Law).
- 3) Foreign nationals who have acquired Turkish citizenship through acquired citizenship / dual nationals in this situation (provided that those studying in secondary education (high school) institutions in Turkey have enrolled before the 2022-2023 academic year),
- 4) a) Students of Turkish nationality who have completed the last three years of their secondary education (high school) in a foreign country other than the Turkish Republic of Northern Cyprus (TRNC) (including those who have completed their entire secondary education (high school) in Turkish schools opened under the auspices of the Ministry of National Education in a foreign country other than the TRNC) who have been attending secondary education abroad before 01/02/2013 may apply for student admission quotas from abroad."
- b) Candidates who started secondary education abroad after 01/02/2013 can apply for admission quotas from abroad for those who have completed their entire secondary education (high school) in a foreign country other than TRNC (including those who have completed their entire secondary education (high school) in Turkish schools opened by the Ministry of National Education in a foreign country other than TRNC),
- 5) Those who have TRNC nationality, reside in TRNC and have completed their secondary education in TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010 are accepted to apply.

#### b) Of candidates:

- 1) Turkish citizens who completed their entire secondary education in Turkey or TRNC,
- 2) TRNC nationals (except for those who have completed their entire secondary education in TRNC high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010),

- 3) Dual nationals whose first nationality is Turkish Republic by birth as defined in subparagraph 2 of Article A (except for those who meet the conditions in subparagraph 4 of Article A),
- 4) Dual nationals, one of whose nationalities is TRNC (except for those who have completed their entire secondary education in TRNC high schools and have GCE AL exam results and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010),
- 5) Turkish nationals or dual nationals whose first nationality at birth is Turkish Republic of Northern Cyprus as defined in subparagraph 2 of Article A, studying in schools under the embassies in Turkey and foreign high schools in Turkey,
- 6)The applications of TRNC citizens and those who renounced Turkish citizenship / Blue Card holders and foreign nationals (except for embassy schools and international private education institutions included in the MOBİS system and foreign nationals who have been to our country within the framework of the project carried out by the Ministry of National Education) who will enroll in secondary education institutions in Turkey as of the 2022-2023 academic year are not accepted.

# **Documents Required for Application**

- a) Certified copy of diploma, transcripts, and translations
- b) Foreign Student Examination Result Certificate / YÖS Result Certificate
- c) Photocopy of Identity Card/Passport (Identity Information Page)

# **Application and Preference Conditions**

- 1) International student applications will be made online by uploading the necessary documents on the official web page of Kilis 7 Aralık University and students do not need to bring their application documents to University again. The applications of those who apply with missing documents or make false statements will not be evaluated.
- 2) Our university's exam (KİYÜ-YÖS), Ondokuz Mayıs University international student exam (OMÜ-YÖS), Turkey International Student Admission Examination (TR-YÖS) and international student exams of other state universities will be accepted.
- 3) The information required for preferences, special conditions, and explanations, if any, are announced on the University's web page.
  - 4) Candidates can apply to maximum 5 diploma programmes.
- 5) In the placement applications for international student recruitment with Samsun Ondokuz Mayıs University Foreign National Student Examination (OMÜ-YÖS), OMÜ-YÖS, TR-YÖS and KİYÜ-YÖS exam results will be multiplied by 1 (one).
- 6) For international student recruitment placement applications with Foreign Student Exams (YÖS) conducted by other State Universities, the result of the Foreign Student Exam (YÖS) exam will be multiplied by 0.9 (zero comma nine).
- 7) If the 2023-2024 international student admission quotas announced in our university remain vacant, additional placements will be taken with secondary education achievement points.

# **Evaluation of Applications and Announcement of Results**

- 1) The evaluation and placement of the preferences of international student candidates are carried out by the relevant commission.
- 2) If their scores are equal in placement, those with KİYÜ-YÖS, OMÜ-YÖS and TR-YÖS scores are placed with priority, if their YÖS scores are equal, the secondary education graduation score is taken into consideration, the candidate with the higher graduation score is preferred, in case of equality again, the younger age is preferred, in case of equality, the decision of the international student commission is taken as basis.
- 3) The evaluation and admission commission may apply a 50% threshold when evaluating applications made to a unit from the same country and making an admission decision if deemed necessary. If the quotas are not filled, candidates are placed in the unfilled quotas according to the order of success without taking this rule into consideration.
- 4) As a result of the placement process; Within the quota, the list of principle candidates is determined according to the score ranking obtained from the announced exams. If the quotas are not filled at the end of the registrations from the main list, students are enrolled up to the quota amount with additional placement. Candidates who do not register on the specified registration dates lose their right to register.
- 5) The candidate's name lists for the primary and additional placement and the documents required for registration are announced on the internet address http://www.kilis.edu.tr as a notification. Registrations are made on the dates announced on the University's website.
- 6) Pre-registered students are required to deposit the TÖMER fee. The registration right of those who do not pay the TÖMER fee in due time is terminated.
- 7) Student contributions are paid within the date range specified on the university web page. The registration rights of students who do not pay their contributions and whose documents are incomplete are terminated and the TÖMER fees they have previously paid are not refundable.
- 8) TÖMER registration fees are refunded for students who take the Kilis 7 Aralık University TÖMER Turkish Proficiency exam at the beginning of the academic year and certify that they are successful at least at B2 level.

#### **Additional Placement Application and Evaluation Calendar**

Announcement of Results: August 18

Issuance of Student Acceptance Certificate: August 18-September 01

Final Registration and Deposit of Student Contribution Fee: September 05 - September 15

The results of application evaluation and placement to programmes are announced on the University's web page. "Letter of Acceptance" is sent to the e-mail addresses they declared during the application to the candidates who have pre-registered to the university and have the right to final registration.

#### Language of Education and Turkish Proficiency Levels

- 1) The language of education and training at the University is Turkish.
- 2) Turkish proficiency levels are determined according to the principles of our University TÖMER directive. Candidates who present a TÖMER certificate obtained from an institution other than our university must take the "Turkish Proficiency" exam held by Kilis 7 Aralık University TÖMER at the beginning of the semester. Students who fail this exam are

deemed to be on leave of absence for the purpose of learning Turkish, and this is decided by the relevant unit administration boards.

- 3) Students who are obliged to learn Turkish can attend Turkish courses organized by TÖMER. The training programme for the Turkish Course is announced on the web page of our university.
- 4) At the end of two years, the registration of the student who cannot provide Turkish proficiency is deleted.

# **Documents Required for Final Registration:**

- a) Candidates are required to obtain a "Study Visa" by going to the Turkish Foreign Representative Office in their country (or nearest) together with the Letter of Acceptance.
- b) Candidates in Turkey must obtain a "Residence Permit" from the Provincial Security Directorates instead of a Study Visa.
- c) The original high school diploma and its Turkish translation certified by a notary public or Turkish Foreign Representative Office,
- d) The original "Certificate of Equivalence" of the high school diploma obtained from the Provincial Directorates of National Education of the Ministry of National Education of the Republic of Turkey or Turkish Foreign Representative Offices,
- e) An official transcript showing the courses taken in high school, grades, and grade point average of the candidate, certified by the high school principal and a copy of the Turkish translation certified by a notary public or the Turkish Foreign Representative Office,
- f) The printout of the result document for those who are placed with the YÖS score made by the universities in Turkey,
- g) A notarized copy of the pages of the passport showing the identity information and validity period of the passport with a study visa and its Turkish translation certified by a notary public or Turkish Foreign Representative Office,
- h) A notarized copy of the internationally recognized Turkish Proficiency Certificate, if any, certified by a notary public or Turkish Foreign Representative Office
- i) Six 4.5x6.0 cm photographs (must have been taken within the last six months, from the front, in a way that can easily identify the candidate),
  - j) Bank receipt showing that the tuition fee has been deposited in the relevant bank
  - k) Signed Declaration of Livelihood Assurance
  - 1) Foreign Nationals Identification Number
- m) Health Report (Our university may request a committee report from a health institution located within the borders of Turkey, when necessary, from students who are placed in the departments).
- n) Other documents to be requested for programmes that admit students to our university by special talent exam.

#### **International Student Obligations**

- a) To carry out the necessary procedures and obtain the necessary documents (YU Number, etc.) according to Turkish Laws
- b) Obtaining a residence permit from the security authorities before starting education (within 1 month from the date of entry with a study visa),
- c) To submit the Student Certificate to the security authorities every year based on the residence permits obtained from the security authorities during his/her education,
- d) In accordance with Law No. 5510, they are deemed to be General Health Insured as of the date of the start of their higher education and fulfil the conditions required by the Law,
- e) To notify the Student Affairs Department of any changes in their personal, marital, and educational status within 15 days at the latest
- f) If they wish to extend their residence during their education, they must obtain a new one from the local security authorities within 15 days after the expiry of the period written on their residence permit, provided that they document that they continue their education,
- g) In case they lose their residence permit or passport, they shall immediately apply to the relevant authorities and obtain a new one within 15 days,
- h) In case they change their educational institutions, residence addresses or contact phones, they are obliged to notify the local security authorities of the places they leave or transfer within 48 hours.
